The actors of these cruelties were put in place and remain in force by the government of The Hon. Governor Mitt Romney and President George W. Bush. Hon. Governor Mitt Romney is representing the Canadian government. Hon. Governor Romney and President George W. Bush are using State of Massachusetts to carry out activities sanctioned under Rome Convention - Crime Against Humanity (07/28/1998) and US/Massachusetts Constitutions.

Hon. Governor Romney and President George W. Bush target our family to divide and rule the Ofume family to find easy path to disrupt our campaign for the President of Nigeria 2011 and campaign for civil liberties. Across America Nigeria families and children are targeted but more than as the families and children of the CHURCH OF JESUS CHRIST OF LATTER-DAY. Few families and children that are subjected to the cruelties which our family and children have subjected can survive and live including attend school and remain within nuclear family.
